We are regular supplier of Scientific Laboratory equipment, Reagent Kits Under GKVK colleges & all over college and research institutes in Karnataka.

With refers to the above subject Dr. A.Sathish working has a professor in Department of soil science & Agriculture chemistry, GKVK (Sujala Water shed Project), Bangalore. He is the main silent technical committee member of Purchase Laboratory equipment for the Sujala Water shed Project REWARD). We also supplied a few of the material in GKVK. Dr. A. Sathish also provided Order for some material to us with some understanding.

I was not able to provide sir as a distributors my capacity to provide 15%.But he does not agree & says kindly don't participate in the tender. Already I committed to another company he said.

I met some person under Sujala Water shed Project - purchase department. Last few year Most of the equipments, material, Furnishing Items purchased by silent technical committee member Dr. A.Sathish from particular vendors with best commission. Than what is a use of tender? We spend money for EMD, Processing fees, Security deposit, and a lot much of burden is there for each tender. We also have a mouth & stomach. But he directly disqualifying in the tender without any valuable points.
