With reference to the subject cited above, your Bid for supply of manpower services under REWARD Program being L1 in terms of percentage of service charge quoted has been accepted. The percentage of service charge accepted is **3.99% (Three Dot Nine Nine Percent Only)** plus applicable GST.

1. The service charge will be reimbursed based on actual manpower services during each month.
2. The service provider shall execute the services as per the conditions laydown in the contract agreement (The final draft of the contract is enclosed).
3. The effectiveness of the contract is from the date on which both the parties signed the contract agreement.
4. The time for commencement of services shall be within 15 days after the date of effectiveness of the contract.

5. The contract period shall be 60 months from the date of commencement of the services or Co- terminus with closing of the project.
6. The service provider shall submit the signed and notarized contract agreement on Rs.200/- stamp paper within 21 days of issue of this letter of acceptance.
7. The consultant shall submit performance bank guarantee valid 60 days beyond the contract period of 5 years, at the rate 5% of the tentative total contract value per year within 21 days of receipt of letter of acceptance. The same shall be released after successful completion of the all Contractual terms and conditions.
